DCS Contract Scope of Work:

PURPOSE: The purpose of the DCS contract is to provide evidence-based parent skill-building services that are individualized to family need, culture and readiness for change. The Department of Child Safety is dedicated to providing families with the right services at the right time, without duplication and with proper sequencing. These services are intended to strengthen family protective factors to reduce risk of child abuse or neglect and enhance parent/caregiver protective capacities so that children are safe in their own homes. The services included in this contract include the following:

- 1. Family Connections, which provides change-focused interventions to achieve the FamilyConnections core outcomes of:**
 - Social Support
 - Family Functioning
 - Family Resources
 - Child Well Being
 - Parenting Attitudes and Behaviors
 - Managing Parenting Stress
- 2. Nurturing Parenting Program, which is a curriculum-based parenting skills education and coaching program to improve parenting in relation to:**
 - Expectations of Children
 - Parental Empathy towards Children's Needs
 - Non-violent Discipline
 - Parent-Child Family Roles

- Children's Power and Independence
